



CP COURSE STIPEND

We would like to offer a limited amount of course stipends to promising individuals who are interested in Computational Psychiatry but do not have sufficient funds available to be able to take part in the Computational Psychiatry Course in Zurich. The course stipend will **cover the costs of the main course and two practical tutorials of your choice** (but does not include additional monetary compensation).

Your Application

You are eligible for a CP Course Stipend if you do not have access to sufficient funds to pay the course fee on top of the travel costs and are currently studying or working in a low to medium income country (as defined by the World Bank, see list below). Participants from lower income countries will be given priority.

Please send **your CV and a letter of motivation** to the CPC organizers (cpcourse@biomed.ee.ethz.ch) **by 25.03.2020**. The letter of motivation should contain both your scientific and your financial motivation to apply for this grant on 1 – 2 pages. Therefore, please highlight your interests and how computational psychiatry is (or will) feature in your research or practice and a statement, why your financial situation makes you eligible for receiving the CP Course Stipend.

Decision

Your application will be reviewed and a decision will be made before the 8th of April 2020.
